**Additional Cost**

**Travel Documentation Requirements**

- Passport (must be valid for at least six (6) months beyond completion of travel)
- If you do not have a Passport: Adult passengers 16 years and older need a valid government-issue photo identification and a U.S. state-issued original or certified copy of their birth certificate (**hospital certificates are not acceptable**).
- Children under the age of 16 may board with a U.S. state-issued original or certified copy of their birth certificate.
- Any passenger that has a different last name on their photo identification and birth certificate must also bring an original or certified copy of a marriage license and/or divorce papers to legally explain the difference between the two names.
- Passengers will be denied boarding for failure to meet these requirements and no refund will be issued.
- If you are a **Non-US Citizen**, please contact Joshua Wright about travel requirements.
